The Decatur County Commissioners opened their November 2nd, 2009 meeting with the following present: Jerome Buening-President, John Richards, Rick Nobbe and Bridgett Weber – Auditor

The October 19th 2009 meeting minutes were approved as read.

Tim Ortman – GIS Coordinator reported that Homeland Security grant monies will be used to update land use layers in the GIS System. The Plotter was also discussed. Wells Fargo has stated that the agreement to terminate will time frame has passed. Commissioners agree that additional letters and telephone calls should be made.

Mark Mohr – Highway Superintendent reported that work on Bridge #30 is currently underway. Mr. Mohr also indicated that he is working with Northwestern to provide the best ways for salt distribution during this winter.
