Meeting was called to order by Judge Timothy Day at noon.

A motion to approve the minutes was made by Jennifer Sturges and seconded by Sheriff Meyerrose. Motion was carried with unanimous approval.

Abby Harry gave report for Court Services.

Project Income Balance: \$124,363.63

CTP Balance: \$24,600.00

Abby reported that there are currently 35 clients being monitored through community corrections. Judge Day gave a brief description of what CTP consisted of, who was a candidate and what the criteria to be eligible for that program entailed. Judge Bailey asked about the number of pre-trial risk assessments completed. Abby stated that while she didn't have the most recent numbers there were approximately 200 completed in June of this year.

Matt Hoeing gave a brief update to the upcoming budget cuts and stated that while there is nothing currently affecting Decatur County Court Services, he anticipates there to be in the future.

The next scheduled meeting will be December 5 at noon, and unless otherwise advised would meet in the EMA Conference Center.

Matt Hoeing also requested permission to explore replacement options and costs for the current 2017 Ford Van. He advised that the decals were currently being removed due to safety concerns for officers using that vehicle.

Chief Mike McNealy motioned to allow for Court Services to explore replacing the 2017 Ford Van and was seconded by Tony Blodgett. The motion was carried unanimously.

With no further business Matt Hoeing made a motion to adjourn the meeting and was seconded by Chief Mike McNealy. The motion was carried unanimously.
